Dear Senior Management Representatives of the BRA,

RE: The land tax law of Barbados is [mischief](#) that must be stopped

I hope this letter finds you and your team well.

What was called land tax is known in the streets of magic as "sleight of hand." My research shows "land tax" was put on the Barbados books in 1972. By default, people that acquire land are the most productive in our society, and we stand ready as a landowners association to help resolve this matter.

Last, for the members of our association to pay you, it would only allow your organization to continue to take away land from people who OWN it. In our hearts, we cannot do this evil to the families that sacrificed so much to gain just a little to get ahead.
